

# East Region Formulary Update—May 2023

# **New East Region Formulary Platform Launched**


Over the last two years colleagues from NHS Borders, NHS Fife and NHS Lothian have been working to develop Scotland's first regional formulary. The core content for the adult formulary has now been agreed and approved by the East Region Formulary Committee, so all three Boards are now able to begin using the new formulary platform.

The platform consists of a purpose-built website and mobile app, which provide a flexible approach to browsing formulary content. Colleagues in NHS Lothian will be familiar with the new platform, as it has been tested within Lothian prior to the roll-out across the whole region.

#### **Conditions and Treatment Pathways**

The formulary has evolved from the traditional BNF structured 'list of medicines' and now presents recommendations using a condition-based structure, which aligns formulary choices to the treatment of the patient. Formulary recommendations are therefore detailed on condition-specific pages, with individual 'Treatment Pathway' sections highlighting different aspects of treatment. These pathways may cover Adult, Child, or Pharmacy First recommendations as indicated by the icons shown here:



#### **Navigating the Website**

The new website offers a variety of navigation options to help you locate formulary recommendations. All are available from a menu bar at the top of the screen, so can be accessed wherever you are on the site. A clever search facility, with suggestions as you type, is also available to make finding formulary content easier.

ß	Conditions A-Z	Access formulary recommendations by medical condition, using a simple A-Z index. This is the quickest method of reaching formulary choices.
೮	Therapeutic Areas	Explore formulary recommendations by Therapeutic Area (chapter). Simply select a chapter name from the list and then browse to the condition-based recommendations.
	Medicines A-Z	Use a simple A-Z index to check whether a medicine is on the formulary. Selecting a generic medicine name will then tell you which condition(s) it is on formulary to treat, allowing you to view the medicine in context.
	Medicine Categories	If you'd like to browse the formulary using the legacy BNF medicine categories, you can do this here.

#### **Mobile App**

The East Region Formulary is also available to access via a mobile app. The 'NHS Scotland Formulary' mobile app has been designed to be used by multiple Health Boards, with the East Region being the first to have access to the new platform.

Like the new formulary website, the mobile app presents condition-based formulary recommendations. The design of the app matches the website in order to provide a consistent experience and it can also be used offline.

You can download the app by searching for 'NHS Scotland Formulary' in the Apple or Google Play app stores.

# **Helpful Flags and Icons**

As you browse the website and app you will see various flags, symbols and icons. Simply hover your mouse over the image (or tap the image if using a mobile device) to check what it means.







# **Easy Access to Other Resources**

Each medicine listed on the formulary has a 'quick links' button to provide direct access to the BNF monograph for that specific medicine, as well as enabling a quick search of the eMC website (for SPC and PILs), Stockley's (for interactions) or SMC advice.



#### **Built Using Recognised Standards**

The new platform uses the NHS Business Services Authority 'Dictionary of Medicines and Devices' (dm+d). This is a dictionary of descriptions and codes representing medicines and devices in use across the NHS, providing a recognised standard for uniquely identifying items used in patient care. All of the formulations detailed on the site therefore use the dm+d description, providing consistency and supporting the future use of formulary data within other systems.



#### **Quick Access to Formulary Decisions**

The website contains purpose-built functionality for locating Formulary Committee decisions on new medicines and formulary applications.

This section does not contain a full list of formulary recommendations, instead it focuses on the outcome of decisions made by the East Region Formulary Committee (e.g. SMC medicines, formulary applications).
